### Dear SPaRC Awards Committee,

It is with great pleasure that the Mechanical Science and Engineering Grants Management Office submits an OUTSTANDING SERVICE AWARD NOMINATION FOR STEPHANIE FELLMANN, Proposal Coordinator in Sponsored Programs Administration Pre-Award. Stephanie has been our assigned proposal coordinator since August of 2015, however our interactions date back further due to her previous positions at OSP(RA). During this time, Stephanie has provided outstanding service in support of the proposal submission process.

Timely and Responsive — Our office is often presented with difficult deadlines in which we are notified of proposals with limited lead time. Stephanie is always quick to respond to any questions we pose to her, which in turn allows us to provide better service to our faculty and submit proposals to SPA more timely. In addition, she shows great poise and professionalism when aiding us in meeting challenging deadlines. Previous co-worker, now department colleague, Scott Corum, said, "Her dedication to her job is outstanding." This characteristic is evident at the departmental level because her customer service is exceptional. In addition to her responsiveness with questions, Stephanie does her best to submit proposals in advance of the deadline as much as possible. As a department, we appreciate this effort so, there isn't a last minute rush to edit documents.

Resourceful and Knowledgeable – Nearly every proposal submission is unique from the one before. At the department level, our investigators regularly make requests that don't follow a "normal" proposal submission. When we don't have the answers to those requests, we turn to Stephanie as a resource, to seek her opinion or direction. We value the depth of her pre-award knowledge and appreciate the extra effort she makes when she seeks out answers on our behalf, ensuring that we have all of the necessary information. Other departments have recognized her expertise, as well. NCSA's Tamara Roosevelt stated, "Stephanie is efficient, knowledgeable, and available for questions. She is friendly and easy to work with, patient, and is always up for our unique NCSA challenges."

Stephanie co-taught a SPaRC'Ed elective class alongside Haruka Brown (undersigned on this letter) and Sarah Lorbiecki. Being asked to teach a SPaRC'Ed class inherently implies that Stephanie is regarded as an expert in her field. During the course of the class preparation and delivery, Stephanie took the lead in organizing meetings and compiling the presentation materials. She conveyed the materials and her knowledge in proposal preparation to broader audiences effectively and effortlessly. Haruka Brown noted, "While preparing for the class, I caught a glimpse of how demanding her work really is. Despite her heavy workload, being under pressure

of meeting tight deadlines, and working through the constant interruptions of receiving a large number of emails/phone calls from units throughout the campus seeking her guidance, she is always willing to provide her guidance and help without hesitation."

Collaborative Effort – In the time since Stephanie has been assigned as our proposal coordinator, our department's relationship with SPA, Pre-Award has improved and strengthened considerably. The proposal submission process now resembles more of a coordinated team effort rather than a compartmentalized one. There is increased dialogue between our office and Stephanie regarding proposal volume, deadlines, and plans to be out of office. This regular communication helps manage the expectations on both sides which renders more reasonable expectations.

Stephanie's impact is far-reaching, as demonstrated by both the letters of support accompanying our nomination and the observations and statements offered by multiple departments across campus. Wendy Balthazor of the College of Veterinary Medicine indicated, "Stephanie is always a pleasure to work with on any proposal that crosses her desk. She is able to quickly and accurately conduct reviews on a large number of proposals across a wide spectrum of sponsors. In addition to providing her customers with excellent customer service, she has also become someone that we, as her departments, know we can count on to always be cheerful on the phone, in emails, or in person when we discuss current proposals we are working on. We believe that Stephanie goes above and beyond to make her departments day-to-day functions operate smoothly."

We hope that our comments, along with those of our colleagues, adequately demonstrate how STEPHANIE FELLMANN PROVIDES OUTSTANDING SERVICE in the "behind-the-scenes," underappreciated task of a proposal coordinator. A quote from her previous supervisor at OSP, now at Carle Foundation Hospital, Kathy Dams perhaps summarizes Stephanie's contributions best, "Stephanie has been a pillar of Research Administration at the University of Illinois for many years, serving as a resource and contributor for departments and administration alike. She emulates outstanding service in all of her interactions, ensuring that research funding is sought in a competitive and compliant manner, while building strong interdepartmental relationships and encouraging a culture of collaboration in research at the University. Stephanie was always an invaluable resource and support to me and our team of Proposal Coordinators when I served at OSP. I'm very pleased and proud to contribute to this well-deserved nomination for a very deserving individual." It is my pleasure to nominate Ms. Stephanie Fellmann for the SPaRC Outstanding Service Award. It is my understanding that Stephanie joined the OSP team while she was a student worker, and the department has been lucky enough to retain her since then. My first interaction with Stephanie was as a customer of the OSP specialist team, in which she sent award notification, questions, and follow-up requests to both UIUC departments, off-campus subawardees, and sponsors in a most timely manner. In her role as Specialist, she often went the extra step, serving as a liaison, when necessary, with more senior staff at OSP in order to answer a question I had asked.

When I was notified in January 2015 that I was being reassigned with Stephanie as my Proposal Coordinator, my only concern was wondering who could possibly replace her previous position. I was thrilled to be working with her on a more regular basis.

Even when I give Stephanie less than a day to review a proposal, she does not simply "rubber-stamp" an approval. Without fail, Stephanie makes me feel as if my proposals are the most important ones in her workload. While the "math" does not work for this perception, (knowing her other department assignments), it is most appreciated by me, and my faculty members.

Her customer services skills are second to none. She never complains about heavy proposal periods; instead, she just explains why her response may be longer than her usual couple of hours. In fact, if I have a non-pressing question, but know she has a heavy deadline week, I wait to ask her, as I know she will not be able to ignore even a non-pressing question or request for help.

While I tend to purposefully serve as a liaison between my faculty researchers and Stephanie, her quality assistance cannot be ignored. #### Dear Evaluation Committee:

It is my great pleasure to nominate Stephanie Fellmann for the 2017 SPaRC Outstanding Service Award, in recognition of her outstanding service in support of research administration at Illinois.

I have known Stephanie since 2010 when I started at the Office of Sponsored Programs (OSP) and she was a student worker. Her outgoing personality and strong work ethic were apparent. She was very diligent with her responsibilities as a student worker. As one of the youngest employees of the office, she took the job seriously and had an advanced understanding of OSP's work processes and how each of the divisions within the office worked together. I was impressed from the very beginning.

Fast forward seven years and Stephanie is now one of the longest tenured staff at OSP. Her dedication has been very evident through the years. I remember a period of time when Stephanie was a Specialist at OSP and staffing was at a critically low level. The units that she supports as a Proposal Coordinator frequently rave about her customer service, work ethic and reliability. She genuinely cares about the people she works with and makes an effort to get to know everyone on a personal level, while also maintaining a positive professional relationship. Because of that, she is well respected by her co-workers and colleagues.

Many within the research administration field view Stephanie as a leader. She is extremely knowledgeable, eager to take on any challenge, and always reliable. When asked a question, she responds quickly and accurately. Stephanie never shies away from a complicated problem or a difficult situation and makes every effort to resolve matters in a timely manner. She also continuously strives for professional development. Thorough attendance at regional and national NCURA conferences, participation in SPaRC'ed presentations, serving on numerous committees, and taking on many different ad-hoc tasks and miscellaneous roles within OSP, she has shown her eagerness to be a leader for OSP and to take the next step in her professional career.

As a recipient myself of the SPaRC Lifetime Achievement Award (2016), I am keenly aware of the many, many deeply committed and highly professional employees whose work contributes every day to the excellence of research administration at the University of Illinois. The SPaRC Outstanding Service Award shall be presented to an individual who has demonstrated outstanding service in support of research administration at Illinois.

To be eligible nominees shall have served the field of research administration at Illinois for a minimum of five years. During the time of his/her service nominee shall have demonstrated outstanding service in support of research administration at Illinois. Nominees will be reviewed based upon their service to the university, college, center, or department. Contributions may be specific to their involvement in SPaRC, presentations within Illinois, involvement in panel discussions, authorship of papers in professional publications, and overall contributions in supporting research administration at Illinois.
