Kara is the Associate Director for Administration at the Beckman Institute for Advanced Science and Technology. Beckman has been a wonderful partner to Carle for over 20 years, primarily in the area of magnetic resonance imaging research and technology. Most recently, Carle and Beckman have partnered on two important initiatives, the Carle Illinois 7 Tesla MRI facility and the partnership between the Cancer Center at Illinois, which is housed in the Beckman Institute, and Carle Cancer Center. I write to enthusiastically nominate Kara Johnson, the associate director for administration of the Beckman Institute for Advanced Science and Technology, for the Sponsored Programs and Research Compliance Outstanding Service Award. Kara is the person who bridges the gap between Beckman's research groups and its administrative staff. She truly understands both sides and uses that knowledge to make sure they complement and leverage each other. Her dedication and perseverance have blazed a trail for researchers at Beckman and their partners in the community and throughout the world. Her hard work makes Beckman the kind of place where interdisciplinary researchers can break new barriers using tools not available anywhere else on campus.

Kara has worked at Beckman for more than 10 years, and has been promoted from the roles of finance specialist, finance coordinator, and director of budget and resource planning. Each promotion gave her significantly more oversight responsibilities within research administration. For example, she has successfully overseen human resources, facilities, IT, and café operations. On any given day, Kara is the mediator who guides our research groups' administrative issues, ensuring that they comply with all policies, laws, and regulations. By reducing the amount of time that these researchers spend on administrative tasks or helping them find compliant solutions, she accelerates the research of the Beckman Institute and the University of Illinois.

One of Kara's most impactful recent accomplishments is the completion of the agreement between the University of Illinois and Carle Foundation Hospital on the planned procurement and use of a Siemens MAGNETOM 7 Tesla MRI system. This magnet, expected to be delivered in fall of 2020, will be the seventh in a clinical setting in the United States. Although the Beckman Institute has a history of collaboration with Carle, this partnership is exceedingly complex due to the shared nature and its location in a clinical setting. Kara navigated the uncharted legal and business aspects of bringing this unique technology to the community by serving as the primary point of contact and establishing the necessary procurement and agreement documents. This required persistence, reliance on her already-strong relationships around campus and at Carle, and bringing together representatives from purchasing, legal, risk management, the Office of the Vice Chancellor for Research and Innovation, and others. Because of Kara's dedication, this approved purchase will bring scholarship, discovery, and innovation that will change the world in ways we cannot yet imagine. Kara also helped create a path and process for other campus units who might want to enter into similar agreements in the future.

Kara is an incredible asset to Beckman's researchers, the institute itself, and the campus research community as a whole. Her relationship-driven approach, data-focused decision making, and tireless dedication to her work make her an excellent candidate for the Sponsored Programs and Research Compliance Outstanding Service Award.
