To the SPaRC Outsanding Service Award selection committee:

I am writing this letter in strong support of Matthew Feely's nomination for the SPaRC Outstanding Service Award. Matt is most deserving of this award. I have been working with Matt for over 4 years since he was assigned as the award coordinator of our campus unit.

I am the Director of the DNA Sequencing Service Laboratory, a unit of the Roy J. Carver Biotechnology Center (CBC). We offer state-of-the-art genomics services and equipment to campus researchers as well as public and private collaborators from all over the US and many other countries. As an example, every week we sequence dozens of genomes from plants, animals, microbes and viruses from researchers from all over the globe. The UIUC has an outstanding reputation in Genome Biology and our lab generates a significant portion of the raw data to investigators in this field. As a large share of our work is with outside collaborating researchers or institutions, a Technical Testing Agreement (TTA) needs to be set up when the work performed goes over a certain dollar amount. This is where Matt comes in, he is the person that negotiates these TTAs with prospective external users of ours and other facilities of the CBC. Many of these TTAs undergo a long process, as some institutions include strange requirements and conditions to the contract that must be negotiated in the best interest of the UIUC. Matt has always been able to negotiate these contracts with a mastery we have not seen from previous award negotiators. He communicates with the Legal Department from the external institutions and works tirelessly and methodically negotiating every single issue, always keeping the perspective of protecting us and the UIUC as a whole. Some of these contracts are for hundreds or thousands of dollars, and with private companies that require strong Non-Disclosure Agreements. In the over 4 years that Matt has been our award negotiator, we have not had a single legal issue with any of these companies or with any other institution. A major reason for this is that Matt always considers all contingencies needed to protect us and the UIUC.

Matt often requests our opinion on contingencies being requested by companies. In these emails, he typically adds his opinion regarding potential positive or negative consequences of each contingency. This helps us a lot in making sound decisions on whether we want to proceed with a contract or a change of course is required.

Another thing that Matt keeps in mind is timing: many of our potential users have research deadlines. If contract negotiation takes longer than they expect, we may lose the ability to perform the work. Matt is very conscious of this timing and gets the negotiations done in the minimum amount of time possible. We see his emails with the institutions, he is always requesting follow up and, if responses are delayed, he again asks if anything is needed on our part. This willingness to keep things on target is highly appreciated by us as it gives us a reputation that we are a good institution to collaborate with.

In summary, Matt Feely has been and is a person that performs his duties with excellence and is dedicated to the success of research at the UIUC. Because of this, he is one of the reasons for our success as collaborators and service providers in ground-breaking, high profile, and expensive research. Setting up contracts with us is not an issue, not something that prevents companies and institutions from all over the work from working with us. For this reason, I strongly believe that Matt's dedication to the UIUC is impactful and he deserves recognition through this award.

It is my great pleasure to nominate Matt Feely for the SPaRC Outstanding Service Award. I base my nomination on Matt's strong support and dedicated assistance to the Roy J. Carver Biotechnology Centers (CBC) with external projects using TTAs, USDA SCAs, USDA RSAs, routing Vendor forms, NDAs, negotiating contracts written by other institutions, and the CBC's Off Campus User Forms for the past four years. Matt's has been involved with routing, proofing, troubleshooting and negotiating several hundred agreements for the CBC. Needless to say, my interaction with Matt is nearly daily with communication of the various complex processing steps.

I am pleased to have Matt's service and support, and especially to have Matt assigned by SPA as point person for processing CBC agreements with external users of our services. Sometimes the agreements submitted fly through processing with little difficulty. Most often, there are glitches induced by the CBC or Sponsor seeking revision of the template. Matt is incredibly skillful, organized, and patient in finding solution and negotiating with the Sponsor. Agreements for the CBC can (frequently are) be challenging to negotiate as they span the globe from a variety of institutions that include University, US Federal or State Govt., Foreign Govt., non-profit Foundation and Institution, and Industry. The volume and complexity of these agreements mean that Matt is juggling processing and negotiating multiple agreements concurrently. His incredible patience, knowledge, and organizational skills lead to seamless multi-tasking and timely success! There have been several agreements that have come back with heavy revision and I naively gave up on finding contractual solution, but Matt is able to pull a rabbit out of his hat and get the agreement executed!

As I have worked closely with Matt for 4 years, I frequently bounce those unusual requests for future projects with Matt to find the best solution before beginning the paperwork. Sometimes just to see if it was possible, or what the accepted overhead rate is for a specific project from a non-profit or work for an external customer using a federal grant with overhead limits. Quite frankly, I and my colleagues at the CBC barrage Matt with an incredible spectrum of questions, and with his deep knowledge and patience gives us the clarity and path forward that we need, or in those rare circumstances where Matt doesn't know, he consults within SPA or UI legal and gets back to us with the correct solution. I am always confident that during negotiation Matt is the advocate of the University of Illinois and the CBC, and will not agree to anything that would put us in jeopardy.

Matt Feely is an incredible resource, helper, and negotiator the CBC collaborates with regularly and his support has greatly benefited the CBC and enabled our work with external institutions to happen. As a result, the reputation of the CBC and the University of Illinois have been enhanced by enabling world-wide collaborations and access the CBC's excellent genomics infrastructure. Matt is deserving of SPaRC recognition, and his service and support with campus units is extremely beneficial to the campus research infrastructure.

On behalf of the Graduate College, we are pleased to submit this letter in support of Matt Feely's nomination for the Sponsored Programs and Research Compliance Outstanding Service Award. From 2018 until 2020, Matt was the Award Negotiator within Sponsored Programs Administration assigned to the Graduate College. In that role, he guided us through the negotiation process for approximately 45 contracts with external funders, all of whom were offering fellowships to graduate students. These contracts differed from each other significantly -- they included contracts with state and federal entities, with private corporations and non-profits, and with foreign governments. Contracts with corporate, non-profit, and foreign entities were particularly challenging, for they often had no standard terms to follow but instead required negotiation more-or-less from scratch. This is where Matt's broad experience, especially that from his years as a Financial Aid Counselor, was particular helpful. He understood the challenges that graduate students face, and this informed his guidance on the terms and conditions that should factor into our contracts. As well, his experience working with private industry, in particular his experience as the Operations Manager at Amazon@Illinois, helped him to see agreements from the funder's perspective, and this too allowed us to craft contracts that were win-win for all involved.

In short, Matt brought the needs of graduate students, the Graduate College, the University, and the funder together as we attempted to forge fellowship agreements that benefitted all participants. Such an effort requires expertise in legal and policy issues, sensitivity to the needs of students, appreciation of the norms of graduate education, persistence with the oftentimes slow back-and-forth communication with funders, and respect for the funders' goals. We in the Graduate College realized Matt's multifaceted skills set, and we came to rely heavily on his guidance. This was especially the case given that the Graduate College does not have a large business office, which means that Matt oftentimes assisted us with steps that other units with larger offices could handle on their own. Matt was forever generous and patient with us, essentially operating as an adjunct business officer for the Graduate College whenever needed.

The most representative example of Matt's exemplary service to the Graduate College was his steering us through our negotiations last year with VinUniversity, a recently founded university in Vietnam. VinUniversity initiated a strategy whereby it would offer fellowships to Vietnamese students to earn graduate degrees at top universities around the world, with the hope that many of those students would return to Vietnam after graduation to join VinUniversity's faculty. VinUniversity sought out the University of Illinois and proposed that we follow the fellowship agreement model that had already been established with other universities. Unfortunately, that model did not fit our operations, and the result was months of negotiation in search of a model that would satisfy both organizations' needs. With Matt's guidance at every step of the way, and with input from the Office of the Provost for International Affairs & Global Strategies, the Office of Business & Financial Services, and International Student & Scholar Services, we finally signed a Memorandum of Understanding that will provide full funding for up to ten Vietnamese students per year for the next five years (and hopefully many years

thereafter). With this agreement, we aim to bring some of Vietnam's most promising students to campus, and we hope to forge a stronger relationship with Vietnam's higher education system.

Matt was central to the VinUniversity MOA. He ensured soundness of the financial arrangements, adherence to applicable laws, compliance with campus administrative policies, clarity of the text, and efficiency of the pre-award and post-award processes. He has contributed this to all of the contracts we have created with him.

In sum, Matt embodies the qualities we most value in a colleague: expertise, energy, creativity, determination, compassion, friendliness, reliability, and straightforwardness. We know that the Graduate College and graduate students all over campus are better off as a result of Matt's efforts, and therefore we heartily endorse his nomination for the SPaRC award.
